SECTION 6: TERMS & CONDITIONS

1. REPAIRS & MAINTENANCE: leesee is solely responsible for all repairs, maintenance, and upkeep of the trailer including tires, brakes, lights, mud flaps, and reflective tape.
2. FMCSA COMPLIANCE: leesee shall maintain full compliance with all FMCSA rules and regulations (49 CFR Parts 390–399), including annual inspections (§396.17), pre/post-trip inspections, DVIRs, required markings, and all DOT safety standards. Renting party must correct any out-of-service violations promptly.
3. INSURANCE: leesee shall maintain adequate liability and physical damage insurance for the entire agreement term. Proof required before possession and upon request. Lapse constitutes breach.
4. DAMAGE: leesee is liable for all damage beyond normal wear and tear.
5. LATE PAYMENT: Late fees per Section 4. Non-payment 30+ days = default, termination, and repossession.
6. TERMINATION: Either party may terminate with 30 days' written notice. Trailer returned in received condition with current annual inspection.
7. OWNERSHIP: Owner retains full ownership. No subleasing without written consent.
8. INDEMNIFICATION: Leesee indemnifies Owner from all claims, damages, fines, and expenses arising from leesee's use of the trailer.
