Afternoon,

After some back and forth with AWAC, we have agreement to offer some additional options from the primary package option attached.

What's presented:

APD - \$2.5k/Unit Deductible – 2.835% on TIV (including minimal non-owned trailer exposure) with \$25k Towing/Storage/Labor/Debris per Occurrence - \$116,916

MTC - \$250k/\$250k Limit - \$250k Reefer - \$250k Terminal - \$25k Pollutant Cleanup - \$2.5k Deductible - \$1.39 on 2.7M Miles - \$37,530

Total - \$154,266 +SLT/Fees

We have agreement on the following options:

APD – 2.7% on TIV for \$20k Towing/Storage/Labor/Debris per Occurrence - \$111,348

MTC - \$250k/\$250k Limit - \$250k Reefer - \$250k Terminal - \$15k Pollutant Cleanup - \$2.5k Deductible except \$5k Reefer - \$1.35 on 2.7M Miles - \$36,450

MTC - \$125k/\$250k Limit - \$125k/\$250k Reefer - \$125k Terminal - \$15k Pollutant Cleanup - \$2.5k Deductible except \$5k Reefer - \$1.10 on 2.7M Miles - \$29,700

All options will have SLT/Fees in addition of approximately ~\$4.25k-\$4.75k.

This has to be an APD/MTC package for AWAC to consider, and binding will be subject to updated expiring term loss runs confirming no increase in incurred losses.
