Dear UIIA Motor Carrier:

This is to advise that your agent, **Parmjit Dhami**, has submitted new insurance information that does not meet the requirements of the Equipment Providers (EPs) with whom your company has selected to do business with under the UIIA. **The certificate of insurance is currently on hold and will not be applied to your account until midnight in order to provide your insurance agent the opportunity to submit a new certificate that meets the requirements of the EPs you do business with.**

On the following page is a list of the information that is missing based on the certificate your agent submitted for your company to be approved for the Equipment Providers that you have selected to do business with under the UIIA. **Your agent will need to submit a new certificate of insurance online through the UIIA web portal to address these items before midnight if your company still does business with the Equipment Providers that require the coverage identified. Absent a new certificate being submitted by your agent, the certificate recently provided will be applied, which will impact your company's status with EPs that require the missing information identified on the following page.**

If your company no longer does business with the Equipment Providers identified as requiring the missing information, you should log into your UIIA account, go to Update Equipment Provider List under Manage Ins Info, and uncheck the companies your company no longer does business with.

Your agent has also been sent a copy of this notice however, we encourage you to contact your agent and urge them to submit a revised certificate of insurance online to correct the issues identified on the following page.
