TQL must approve all accessorial terms/charges in advance and in writing. Payment of detention is determined on a load-by-load basis. Unauthorized charges will not be paid. Detention payment does not begin for at least 3 hours unless otherwise agreed to in writing. To qualify for additional compensation, the Carrier MUST notify TQL at least 30 minutes before beginning detention time and when arriving-on-time/departing from all shippers/receivers (unless the shipper/receiver will notate check in/out times on the paperwork). TQL reserves the right to deny all additional charges unless communicated in advance writing and invoiced to TQL within 90 days of load completion. All demurrage, detention, and per diem charges must be communicated to TQL in writing within 30 days of load completion in order to validate and/or dispute with the steam ship line directly. TQL reserves the right to deny all demurrage, detention, and per diem charges communicated more than 30 days from invoice date. Carrier must file any disputes in regards to demurrage, detention, and per diem charges in writing with the billing party within 7 days from date of invoice.

#### **Carrier Requirements:**

Driver(s) MUST accept and maintain tracking services throughout transit. Failure to accept TQL provided tracking within a timely manner will result in removal from the shipment prior to dispatch for non-compliance.

One of the following tracking systems must be accepted and maintained throughout transit:

Failure to maintain tracking throughout transit may result in damages/fees being assessed for non-compliance.

All loads must be run on company owned equipment. IF carrier is utilizing leased or rented equipment this must be disclosed prior to accepting the carrier rate confirmation.

- Upon disclosure of rented or leased equipment the carrier MUST provide lease agreements, a list of scheduled autos, truck/trailer identification numbers as well as emergency contact information of the leasing party.
- □ □ □ □ □ □ Failure to disclose this information within a timely manner will result in removal from the shipment prior to dispatch.

All trailers MUST be food grade compliant: clean, dry, no holes, leaks, odors, and free of debris.

Upon arrival to shipper, if a trailer is deemed non-compliant carriers will not be issued a TONU compensation for detention due to cleaning efforts.

Driver(s) are responsible for notifying TQL immediately of any irregularities in the loading/unloading process (inaccurate BOLs, Counts, Commodities, OS&D, etc.).

Driver(s) MUST ensure that the load is properly secured for transit. IF the shipper applies a seal at loading the seal # must be recorded on the BOLs and remain intact throughout transit.

If driver/carrier fails to note reefer BOLs with requested info prior to arriving to delivery, this can result in delayed payment and possibly non-payment of freight charges.

#### **Detention Requirements:**

BOLs/PODs must be submitted to TQL within 24-hours of delivery. Failure to provide PODs within this time frame may result in delayed payments or forfeiture of requested detention/accessorials.

In/Out times must be listed on the BOL, legible, and signed off by the shipper/receiver for detention eligibility.

Do not pay for lumpers at the receiver. You are not to be charged any lumpers. Call TQL if the receiver is attempting to make you pay for a lumper. If payment is made for a lumper, you are liable for payment and will not be reimbursed.

Late delivery may result in non-payment of freight charges, and special damages as a consequence of being late may apply. This includes, but is not limited to, freight charges for expedited shipments, packaging materials, additional labor charges, storage charges, spoiled product, loss of sale, the expense of any additional equipment, service, or alternate transportation arrangements that need to be utilized as a result of late delivery.
