if name or address changes from that given on the registration you must notify the Secretary of State within 30 days.
The motor vehicle excise tax is a local tax. Funds raised through the collection of the excise tax remain in your community.

The owner of the vehicle must provide a signed statement attesting that use of the vehicle from which the credit is being transferred is totally discontinued. **"Totally discontinued"** means that the owner has **permanently** discontinued all use of the vehicle except for selling, transferring ownership of, junking or abandoning that vehicle. If the owner who has totally discontinued use of a vehicle later seeks to register that vehicle, no excise tax credits may be applied with respect to the registration of that vehicle or any subsequent transfer of that vehicle's registration.
